 2 coats DecoBase I/ Color MP mix @ .12 gals sq. yd total
 1 coat DecoColor MP @ .04 gals sq.yd.

STANDARD CONCRETE INSTALLATION

New Construction • Acid Etch with Concrete Preparer.
 Level with Court Patch Binder.
 Ti-Coat as Primer.
 1 coat Acrylic Resurfacer @ 0.06 gals sq. yd.
 2 coats DecoBase I/ Color MP mix @ .12 gals sq. yd total
 1 coat DecoColor MP @ .04 gals sq.yd.

LINE MARKINGS:

Apply one coat of 100% Acrylic Deco Line Paint with a roller, brush or airless sprayer.

MAINTENANCE GUIDELINES:

Keep courts free of dirt or debris, wash with water monthly.
